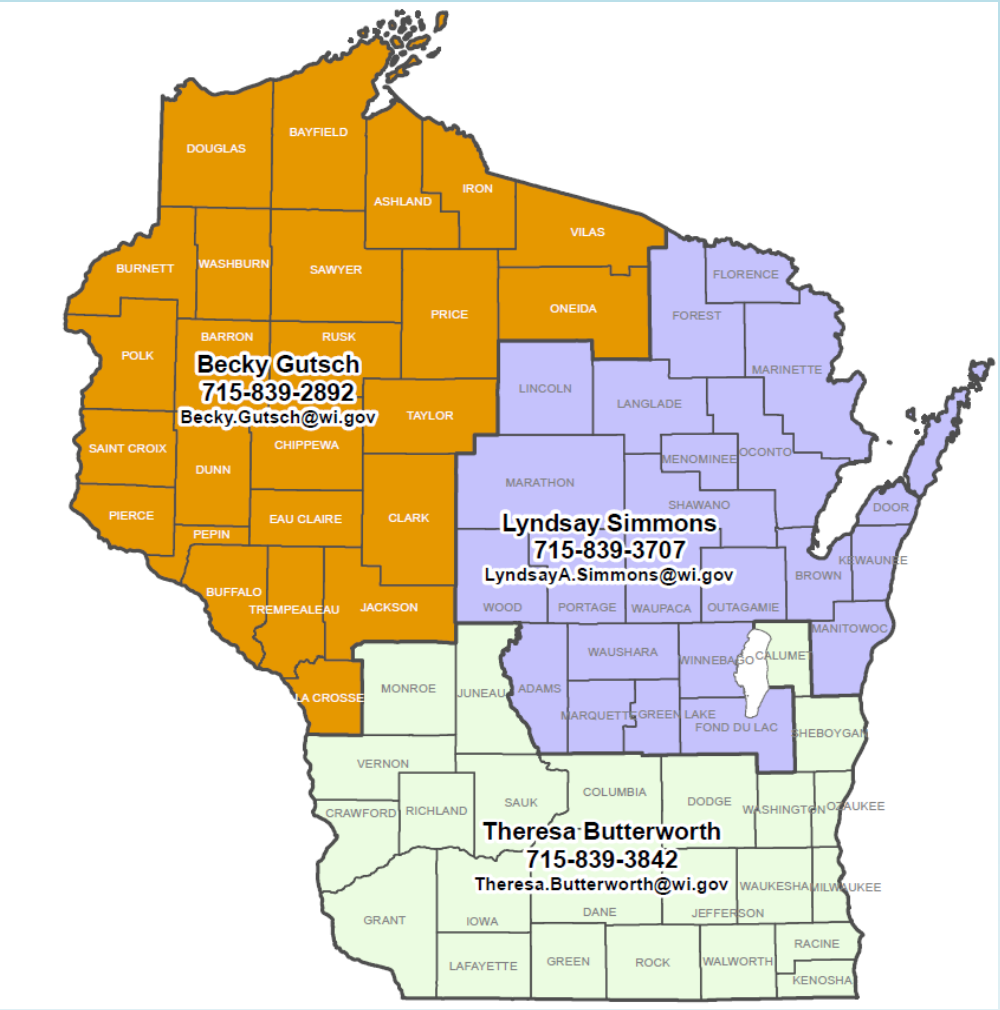

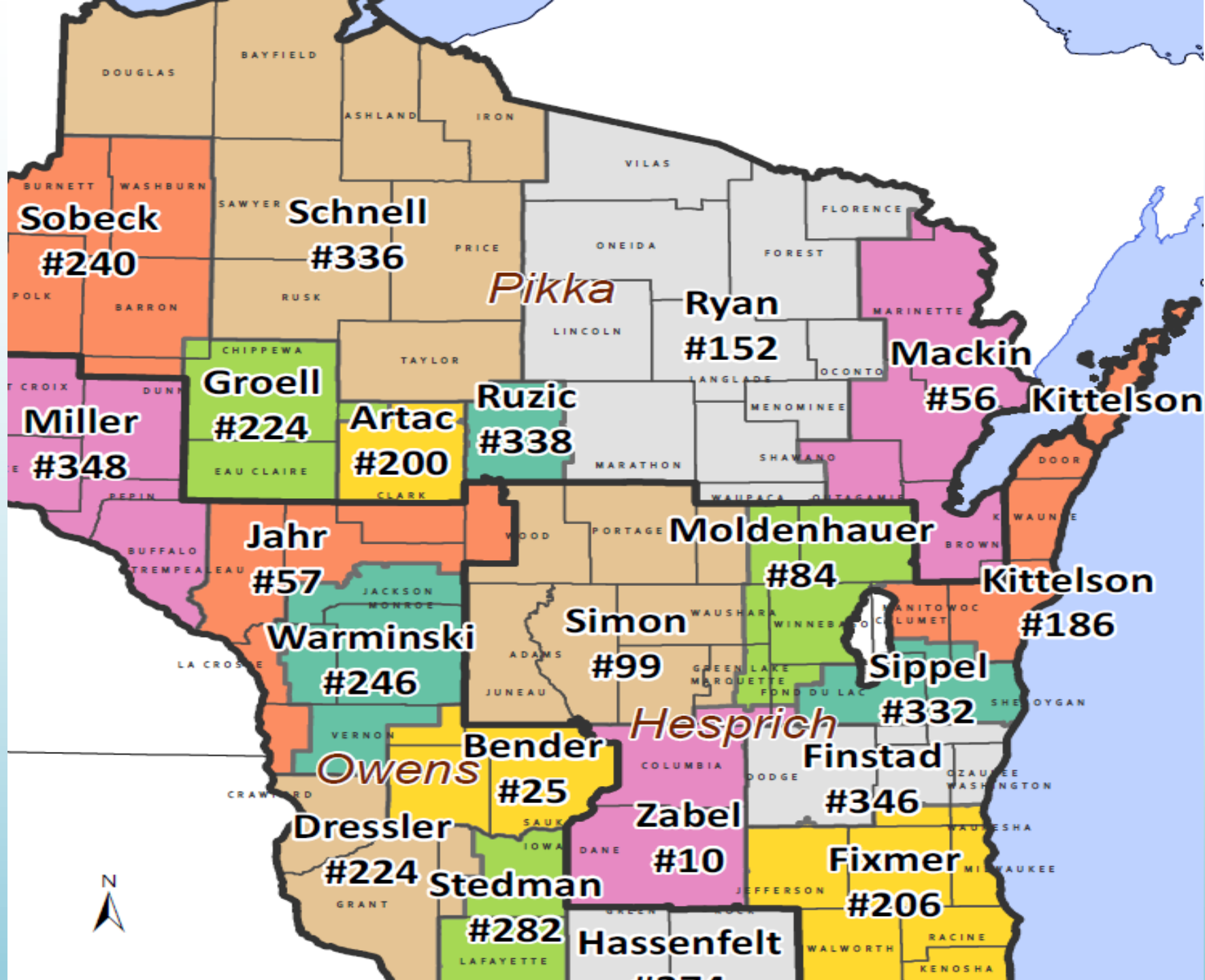
- Get to know the Sanitarian
