- ▶ Separated out three supervisors to cover only Dairy staff

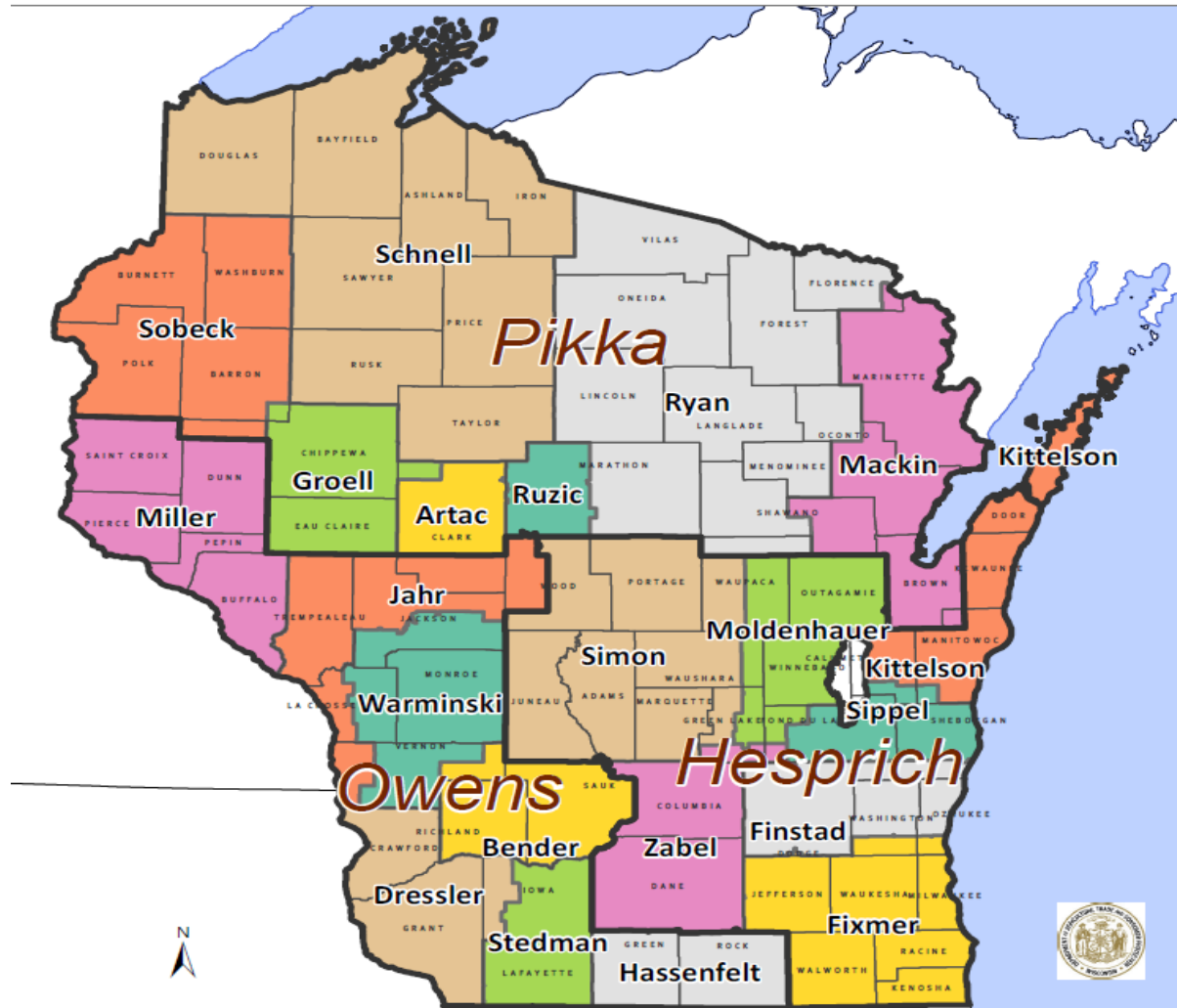
Staff changes

We heard from you about consistency in farm inspections

- ▶ We have improved staff training
- ▶ Improving consistency in updated procedures
- ▶ Focused on marking violations and following up on survey items
- ▶ Stable staffing areas
- ▶ We write all the violations we observe
- ▶ State and Federal surveys

Team or partnership

- ▶ Even in our current climate we need to work as a team to meet the regulations and protect the image of Wisconsin's Dairy industry
- ▶ Work with Supervisors
 - ▶ if you have concerns with debits
 - ▶ Re-inspections
 - ▶ Or degrades

BMWS Pilot

- Win -Huge efficiency gain for staff time
- Win - for industry

Former Process

- ▶ 1 inspection/day/inspector
- ▶ 4 hours/inspection
- ▶ 175 inspections/700 hours

Lean Project

- ▶ 32 inspections/day/inspector
- ▶ 15 minutes/inspection*
- ▶ Can conduct 8 times as many inspections in half the time.
